2.0 SIDEWALKS

Dr. Burke informed the City that the suggestion for sidewalks west of Meridian on 71<sup>st</sup> St. had been made.

Carol Neugent stated that the City has again applied for the Safe Route to School grant for sidewalks going from Main St. on to Sarah Lane to Haysville Middle School. They are waiting to hear whether they have qualified for this grant, but they have been informed that the Meridian and 71<sup>st</sup> area will not qualify for the grant.
