Re: Elementary *Wonderworks* Reading Intervention Materials

Date: May 3, 2016

History/Relevance: We adopted *Wonders*, the current reading curriculum materials, in 2014. While there are resources in the program to differentiate, *WonderWorks* provides additional scaffolding and interactive resources for accessing complex text when a child struggles with reading or writing. It also connects intervention to the core content by reinforcing the same Essential Question, topic, skill, and strategies.

What: We are asking for approval to purchase through Federal funds the McGraw Hill Intervention Materials, *WondersWorks*, for our elementary classrooms serving readers who struggle.

Why: These materials give us the benefit of having tiered reading materials that align directly to the *Wonders* materials adopted in 2014. There are Federal funds that would be used to make this purchase so there will be no impact on the District Textbook Fund.

Where: The *WondersWorks* materials will be in all buildings in the district to support our Literacy First block and MTSS Tier II/Tier III.

When: These materials would be in our buildings beginning in the 2016-2017 school year.

How: Once materials are approved, we will provide training for staff as well as additional support to the Learning Facilitators to sustain implementation.

Who: This proposal will allow us to provide our teachers additional resources aligned to our current reading materials to best support our most at-risk readers.

How much: The total is \$70,713.84. The quote is attached.
